



ASCUTNEY MOUNTAIN EQUINE PLEASURE RIDE
CO-SPONSORED BY VERDA AND ASCUTNEY OUTDOORS
SATURDAY, OCTOBER 5, 2019 at 9:30 a.m.

Please join us for the first pleasure ride on Mount Ascutney co-sponsored by VERDA and Ascutney Outdoors. The trail is approximately 9.5 miles with an optional shorter loop of 6.6 miles, on beautiful Mount Ascutney and surrounding area, mostly on woodland trails and some road. Lunch and soft drinks provided by Brownsville Butcher and Pantry will be served after the ride.

Ride briefing at 9:30 a.m. Depart for ride at 10:00 a.m.

Entry Requirements: Negative Coggins test and proof of rabies vaccination are required with entry. ASTM SEI approved helmets must be worn by riders. Waivers must be signed by all riders and parent or guardian of Juniors (under 18 years of age)

Directions: Ascutney Outdoors Center – 449 Ski Tow Road, Brownsville, Vermont 05037. Ascutney Outdoors Center is just 15 minutes from Interstate 91. From the North, take Exit 9 onto Rte 5 South through Windsor, then turn right onto Rte 44 West to continue toward Brownsville. From the South, take Exit 8 to Rte 5 North then veer left to Back Mountain Rd (Rte 44A) to Rte 44 West toward Brownsville. Turn left onto Ski Tow Road – look for Ascutney Outdoors and Trails signs.
